

REGISTRATION OF SERVICE PROVIDERS ON THE NATIONAL TREASURY CENTRAL SUPPLIERS DATABASE (CSD)

This advert aims to inform all prospective service providers of the CSD system which was launched on the 01st September 2015 by National Treasury. Government has introduced several supply chain management reforms in order to modernise public procurement as per a Cabinet resolution dated 10th December 2014.

In order to streamline the processes which made it difficult for various service providers to do business with the State, the CSD has been established to ensure one central point of supplier registration and to facilitate the verification of supplier information.

With effect from the 01st July 2016, the various State Institutions may only utilise the services of service providers registered on the CSD. Prospective service providers, who have not yet registered, may register themselves directly by following the link: www.csd.gov.za

All prospective service providers who do not have the capacity to register themselves on the CSD, are hereby invited to attend one of the following Supplier Registration Days to be held at the following districts:
