yokwakha izothengwa kosomabhizinisi basekhaya.

Ngiyabonga ukunginikeza lelithuba lokukhuluma namalunga omphakathi ka-Masipala wethu omuhle. Ngithanda ukuqala isonto lami ngokucaphuna umbhali wami oqavile nengimkhonzile, uLailah Kita, we Pearls of Wisdom, owathi "uma sinikwezwe ithuba lokusebenza, kumele sisebenze ngokuzimisela."

Somlomo, loku okucashunwe ngaphezulu kuhlezi kuyisikhumbuzo ukuthi njengoMasipala sisebenza ngakho konke

okusemandleni, nokuthi siyawubandakanya umphakathi. Ukulethwa kwentuthuko nqangi akungathandabuzwa kumele kwenzeke ngokushesha. Kuyangithokozisa ukubika ukuthi ezindaweni eziningi ezingaphakathi ku-Masipala wethu sesenze intuthuko enkulu emkhakheni ethile, ikakhulukazi kulamasonto amabili adlule. Ukwethula ngempumelelo umkhankaso obizwa nge 'Separation at Source' kube yisiqalo esihle kakhulu, njengoba siqeda futhi sihlela ukunciphisa udoti. Izinyathelo ezenziwe u-Mnyango wezokuthuthukiswa kwemisebenzi yomphakathi ku-Masipala wase-Nyukhasela kuzoshintsha izinto kohulumeni basekhaya. Impumelelo yalephrojethi ilele ekuzimiseleni kwabahlali ekusebenzisaneni ngokubambisana nathi. Konke esesikwenzile singumasipali kungenxa yokuzinikela komphakathi wethu. Umasipala wase Nyukhasela uzishaya isifuba ngokuba u-Masipala osebenza ngokuzimisela ukuletha intuthuko, nobakhathalelayo abakhokhi bentela. Ngicela bonke abahlali babambisane nathi njengoba sithuthukisa ukulethwa kwentuthuko kubona.



Ngiyakuqonda ukuthi ubugebengu yiyo yodwa into engama endleleni yokuletha impumelelo, Izimali uma zingasebenzanga ngezindlela ezikhishelwe zona, noma uma zingekho ukushintsha izimpilo zomphakathi. Kwimizamo yethu yokuqeda ubuqhophololo, uMasipala ukhiphe umbiko ngesikhathi somhlango wekomidi, othulwe ngabe 'Ongoti Forensics'. Siqinise isandla lapho sikhuluma nalaba abaphula umthetho noma labo abathintekayo ekwenzeni kobubi. Sizibophezele ekubhekaneni nezenzo zenkohlakalo ngaphandle kokunanaza, ukwesaba nokuba nomusa.

Somlomo, kuyangijabulisa ukubika ukuthi abasebenzi ba-Masipala avela e-mnyangweni wezobuchwepheshe asebenze ngokungakhathali nokuzimisela isonto lonke ukusheshisa ukufakwa kotiyela kanye nokwakhiwa kwemigwaqo emisha, kubalwa umgwaqo uDavy no Edison. Abasebenzi ba-Masipala bamatasa balungise amapayipi amanzi baphinde bakhe kabusha imisele egelezisa amanzi kuzo zonke izigceme eziphansi kwa-Masipala. Lentuthuko isilethe enkulu inkululeko ezindaweni ezithile.

Kulelisono sisungule ngokusemthethweni umkhankaso wenyanga yezokuthutha, lapho bekuhlolwa khona isimo sezimoto nabashayeli. Lomncimbi ube yimpumelelo.

Somlomo, kuleli sonto silalelisise kahle izikhalazo nezinquinamba abahlali base Siyahla-la abahlangabezana nazo. Njengo-Masipala olalelayo nokhathalayo, sibe sesisungula iqembu eliphezulu lemikhakha ehlukeni elizobhekelela izikhalo zomphakathi. Ngibe sengicela ukuba bangilungisele umbiko ophuthumayo. Uma sesithole wonke amaqiniso, sizobuyela kubahlali base Siyahla-la ngeziwu- 21 ku Mfumfu 2020, bese sibabikela ngombiko esesiwutholile. Izimpendulo zethu zomphakathi wase Siyahla-la ngeke zibambezeleke nakancane.

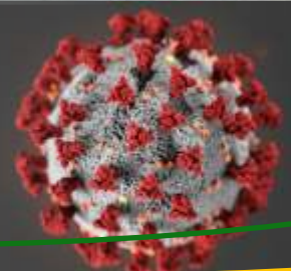

UKUBAMBANA NGEZANDLA UKUGCINA INYUKHASELA IHLANZEKILE

Ngezi 8 zikaNdasa 2019, uMongameli Cyril Ramaphosa wathula ngokusemthethweni umkhankaso wezenzo ezinhle endaweni yase Eastern Cape. Inhloso yaloluhlelo bekuwukukhuthaza zonke izakhamuzi ukuthi zihlanganyele noHulumeni, ukukhuculula izindawo zabo, zomasipala wabo maduzane kuzoba amakhona wonke womhlaba. Ngokwa Mongameli lokhu kungafinyelela emphakathini onobungani bemvelo futhi kufake isandla ekuxazululeni imfucuzo nokugcwala ezindaweni ezithile.

Kamuva kulo nyaka uMeya woMasipala waseNyukhasela uKhansela Dkt Ntuthuko Mahlaba wethule ngokusemthethweni uhlelo i#Gcina iNyukhasela ihlanzekile, elihlose ukuqwashisa amalunga omphakathi ukugcina indawo yabo ihlanzekile futhi ihlose ukufundisa ngokulahlwa kukadoti ngaphakathi kuMasipala. Loluhlelo selukhule izigaba eziningi, laheha izigidi zamovolontiya. Khona kunjalo, imithetho yemivalelandlini yeCovid-19 ifake amabhuleki kuloluhlelo ukuthi luqhubeka.

Manje njengoba umhlaba usesigabeni sokuqala, uMnyango Wezemvelo, Amahlathi kanye Nezokudoba Abaxhumanisi Bentsha (YEC), Ukweseka koHulumeni basekhaya (LGS) behlangene nabazuzi be Thuma Mina Good Green Deeds, noMasipala waseNyukhasela baphinde bavuselela le nqunquthela yokukhuculula. Indawo ekuqalwe kuyo isesikhungweni samabhasi kanye namatekisi aseNyukhasela, uhlelo lwalo ukuhambisa amanzi avinjwe imfucuzo.

Inani labantu elandayo liyalingana futhi liyahlangana nokuthutha kwemifucuzo. uMasipala usethule umthombo wokuhlukanisa udoti emthonjeni, ekuzameni izindlela zokunciphisa ukulahlwa kukadoti, ngokuphambukisa okungenani imfucuzo e ng a m a p h e s e n t i a n g a m a s h u m i ayisishagalolunye nantathu (93%) ezindaweni zokulahlwa udoti. Loluhlelo lihlose ukwakha amathuba omsebenzi kwezinto ezivuselelwa kabusha nalabo abafisa ukuqala amabhizinisi emikhakha yemfucuzo.

Ukukhiqizwa kwemfucuzo kuyanda ngokukhula kwenani labantu futhi kubalulekile ukuthi kubhekwe kabusha umfanekiso wokukhiqiza nokugcina kabusha kwezinto ezisetshenziswayo, ubhekise ohlelweni olubizwa ngokuhlukaniswa kukadoti elisungulwe uMasipala ngoMandulo inhloso yayo enkulu kwakungukunciphisa imfucuzo ngokuphambukisa okungenani ngamaphesenti angamashumi ayisishagalolunye nantathu (93%), kude nasezindaweni zokulahlwa udoti.



Inhloko yezokuxhuma nomqondisi we Eyabantu, nencwadi yezindaba yakaMasipala izwakalisa ukugculiseka okukhulu ngemiphumela emihle nenqunquthela ewutholile ovela emphakathini.

“Kuyajabulisa ukwazi ukuthi kunomthelela omuhle ngalesisinyathelo. Indawo enhlanzekile nebukelayo ilethe isithunzi emphakathini futhi iphinde ikuveze ukuthi

abafundi bethu bayayibona imizamo kaMasipala. Siyaqhubeka nokunxusa amalunga omphakathi ukuba aqhubeke nokuxhumana noMasipala ezinkundlweni zokuxhumana nokwazisa ngezinhlelo ezinhle ezenzela kuloMasipala. Iphephandaba elisha lakavuma lakaMasipala indlela enhle elungile yokuthola ngezinto zonke ezenzakalayo kuMasipala, kusho uMlungisi Khumalo”.

Umnyango wezamanzi kuMasipala waseNyukhasela uqhuba uhlelo elinomphumela omuhle wokulwisana nenkinga yamanzi nokuqhuma kwamapayipi. Umphakathi waseNyukhasela ungakhululeka wazi ukuthi umasipala uyayinqoba impi ebikade inganqobeki. Iqembu liyaqhubeka nokusebenza ngokuzikhandla imini nobusuku, ukuqinisekisa ukuba amapayipi aqhumile ayalungiswa ngokukhulu ukushesha.

Ukunciphisa isimo sokuqhuma kwamapayipi nokuthola isisombululo sesikhathi eside, Umnyango wezamanzi ufake ama-valve azohlukanisa ukuze kuvaleka izindawo ezincane uma kunepayipi eliqhumile, bese ngokushesha kufakwe amapayipi amasha.

Unjiniyela wezezamanzi, uMnu Manqoba Shabalala uthi abezobuchwepheshe bakhishwa njalo uma kubikwe ipayipi eliqhumile noma amanzi avuzayo, bese bafaka elisha ngokushesha. Ngokuka Shabalala, lendlela ayongi kuphela isikhathi kodwa futhi ayiphazamisi umphakathi ngokunqamuka kwamanzi.

“Okwethu ukunciphisa inani lamapayipi aqhumile ngokushesha. Sinethemba ukuthi lokhu kuzoba njabulo emphakathini wethu, lokhu kuphinde kusho ukuthi amathangi amanzi asethunyelwa kwihlanzana labantu uma sibe nokuqhuma kwamapayipi. Ukwethulwa nokufakwa kwamapayipi anciphisa incindezi kuzojika izinto,” kungeza uShabalala. Uphinde washo ukuthi ngesikhathi amapayipi amadala (PRVs) ekhandwa, ayengenazo izisefo ezibamba udoti emapayipini kodwa kulawa wamanje afakiwe asenazo izisefo, lokhu kuzokwenza kubelula ukugeleza kwamanzi emapayipini.

Umqondisi omkhulu wezamasu wezinsizakalo zobuchwepheshe, uMnu. Sydney Chauke, uqhuba wathi uMasipala uphuthumisa imizamo yokubukeza izinkinga zamanzi. Unxuse amalunga omphakathi ukuba ubike ngokuvuza kwamanzi kulenombolo (0860) 144 144.

Inhloso yaseNyukhasela yokuba nguMasipala ongenazo izikhinsi emgwaqeni isheshe yafezeka, lomsebenzi wokuzikhandla uhambisana nemizamo kaMasipala yokubuyisa nokwakha kabusha izinhlelo zamanzi ezikhukhula ngokushesha okukhulu. Ngokuhlanganyela ne 'Operation Khawuleza' uMnyango Wezobuchwepheshe kaMasipala uhamba phambili, futhi uhlanganisa indawo enkudlwana ngemizamo yokwenza imigodi ibe yinto yesikhathi esedlule.

Kuleli sonto, amaqembu ahlukeni avela eMnyangweni Wezobuchwepheshe athunyelwe ezindaweni ezahlukeni kuMasipala ukuqala ngohlelo lokulungisa imigwaqo nokwakhiwa kwamapayipi amanzi. Amaqembu aqale emgwaqeni u-Edison kanye no Davy endaweni yezimboni eNyukhasela, imigodi lena isiphazamise kakhulu abashayeli emgwaqeni.

Oyimenenja Yezemigwaqo kanye Namanzi Esiphapho, UDkt Thava Kelly uthe uMasipala wazi kahle ukuthi imigwaqo ethile ibe nomthelela ongakanani ezimotweni, kepha usamile ngokuthi imigodi kuzoba yinto yesikhathi esindlule.

“Injongo yethu enkulu okwamanje

ukuqinisekisa ukuthi silungisa imigodi eyodwa ngesikhathi. Lenqubo izosheshiswa futhi ilandelelwe ngokushesha. Ngiyazigqaja ukuthi amaqembu ethu asebenza ngokuzikhandla ukuxazulula lenkinga. UDkt Kelly uphinde wengeza ngokuthi umasipala ulandela ngokushesha lenqubo yokwakha kabusha nokulungiswa kwamapayipi amanzi ngesikhathi ukuvikela ukugcwala kwawo.

“Siphinde sakha izindawo ezahlukeni lapho amanzi ezimvula edonswa khona endaweni yase Madadeni esigcemeni 29 ukunciphisa izinga lamanzi avela emvuleni, eyenza lendawo ibenezikhukhula. Sakhe okuzosebenza njengomsele wamapayipi owenziwe ngokusemthethweni ozoqoqa ukugeleza kwamanzi okuhambisa indle yomphakathi”.

Umqondisi Omkhulu Wezamasu Wezinsizakalo zobuchwepheshe, uMnu Sydney Chauke uyishayele izandla imizamo evezwe iqembu Lezobuchwepheshe. Unxuse amalunga omphakathi ukuthi abekezele wathembisa umphakathi lenqubo izofika kuzonke izigceme.

Unqongoshe wezobuciko namasiko uNkz. Hlengiwe Mavimbela ephelezelwa usodoloba womkhandlu waseNyukhasela uDkt. Ntuthuko Mahlaba bavakashele imitapo yolwazi yaseNyukhasela kanye nowase Charlestown, ngenhloso yokuqinisekisa ukuba imithetho yeCovid-19 iyagcinwa.

Inhloso yaloluhambo kwakungukuhlola ngokuphelele isimo sokulungela kwalezi zikhungo ezibaluliwe ngenjoba yonke imitapo yolwazi KwaZulu-Natal ebikade ivalwe ngokusemthetheweni ngenxa yemithetho yemivalelandlini. Ngokulandela imithetho kamongameli uCyril Ramaphosa yokungena kwezwe esigabeni sokuqala somvlelandlini, umnyango kazwelonke kwezobuciko namasiko uthathe isingqumo sokuthi imitapo yolwazi iphinde ivulwe futhi.

Unqonqoshe uMavimbela wenze izinkulumo ezincomayo ngenkathi ehambele emtapeni wezincwadi waseNyukhasela. Ungqonqoshe ushaye uMasipala ihlombe ngokuba nemitapo yolwazi enakekelwa kahle kakhulu esifundazweni. Uphinde wagqugquzela nabasebenzi ukuba baqhubeke nomsebenzi wabo omuhle kodwa wabe esebaxwayisa ukuthi baqhapse ngokweqile njengoba iCovid-19 isekhona.

UMeya Womkhandlu waseNyukhasela uKhansela Dkt. Ntuthuko Mahlaba usebenzise

lelithuba ukuqinisekisa abasebenzi ukuba zonke izinto ezibalulekile, izinsiza kusebenza (PPE) zizonikezelwa, nanokuthi uMasipala usethole indlela elula yokunciphisa igciwane lekhuvethe. UDkt uMahlaba njengo mfundi oqavile, unxuse amalunga omphakathi ukuba asebenzise umtapo wolwazi ukusiza ekuqiniseni usiko lokufunda nolwazi.

“Ukufunda kuyisisekelo esibalulekile esikhuthaza ukukhula kwemfundo, okuyinhloso nenjengo yokufunda izinto ezintsha. Nginxusa amalunga omphakathi ukuba baqinisekise ukuthi njengoba imitapo isivuliwe, kwazibani, mhlampe umbhali oqavile olandelayo ukhona la eNyukhasela,” kusho uDkt Mahlaba.

Ngesikhathi unqongoshe evakashela iFort-Amiel Mnyuziyemu, umgcini wamaciko asemandulo uveze ukumangala ngendlela uMasipala ogcine ngayo amagugu. Ngaphandle kokusha kwakamuva koMnyuziyemu, okwakudalwe ngubuhanguhangu bamalangabi, bakwazi ukusindisa u90% wezinto zamaciko emlilweni.

“Umnyuziyemu lona unotho kakhulu ezintweni zomdabu esifisa ukuzigcinela isizukulwane esizayo. Ngihlabeke

umxhwele ngendlela izindawo esizivakashele ezingakhona. Ukuzinikela kwenu kuyancomeka njengabasebenzi,” kusho unqongoshe uMavimbela.

uNqonqoshe ugqhugqhuzele ukubaluleka kwemithetho yesegaba sokuqala. Umphakathi uyanxuswa ukuba ulandele imiqathango yemihlahlandlela yokuhlukanisa umphakathi ebekiwe kuzozonke izakhiwo mawungena.
