Preference points will be awarded to service providers based on Reconstruction and Development Programme – Government Gazzette :16085(1994) initiatives. The bids will remain valid for 120 days. The Council reserves the right to accept all, some, or none of the bids submitted, either wholly or in part and it is not obliged to accept the lowest bid.
