## Lightning strike kills one

KwaZulu-Natal Provincial Disaster Management teams are responding to the trail of destruction left by severe thunderstorms accompanied by strong winds and lightning in the areas of Dannhauser, Estcourt, Vryheid, and Ulundi.

One learner was killed during severe weather conditions, when three learners of Mandlamasha Primary School in Dannhauser, Amajuba District, were struck by Amajuda District, Were Struck by lightning on their way home from school on Monday, 5 February. KZN MEC for Cooperative Governance and Traditional Affairs (CoGTA), Bongiwe Sithole-Moloi, expressed condolences to the family of the departed learner and wished a speedy recovery to the two learners who were hospitalised.

"It is deeply sad that such a young person has left us in a tragic manner. We express our deepest condolences to the family and we wish a speedy recovery to the other two learners who are in hospital. Our disaster team will reach out to the families as per our normal procedure to assist families affected by such incidents," said MEC

Sithole-Moloi.
A number of households in these areas were severely impacted as strong winds tore off roofs, causing damage to the valuables of many families. Public infrastructure was not spared from the disasters and

power lines were also destroyed. resulting in power outages in some

Initial reports suggest that the most affected areas were Wembezi in Estcourt, under the Inkosi Langalibalele Local Municipality, which was damaged by thunderstorms and strong winds. Nhlazatshe in Ulundi saw damage caused by strong winds and Ozwathini and Mhlongo farm under Abaqulusi Local Municipality, were damaged by the hailstorm.
MEC Sithole-Moloi has instructed the disaster teams to work together with all affected municipalities. "It is deeply saddening that the inclement weather has caused yet another disaster in our province, as many municipalities are currently repairing homes and infrastructure after last month's heavy rains. We have sent teams who are currently on the ground to assist affected families with immediate relief and to attend to the needs of those

We have coordinated with other departments to come to the aid of affected families. Some families have lost their valuables such as furniture, important documents and medication. We are engaging with the Department of Health, Home Affairs, and SASSA to assist with the replacement of important documents and medication," said MEC Sithole-Moloi.
