Local Production and Content Requirements- This bid will be evaluated for Local Production and Content. Only bids that achieve the minimum stipulated threshold for local production and content may be evaluated further. The stipulated threshold percentages for local production and content are as follows

- Steel Substation Structures, Street Light Steel Poles, 100%
- Electrical and telecom cables, 90%
- Valves products and actuators, 70%
- Conveyance Pipes, 80% 100%
- Transformers and Shunt Reactors, 10% 90%
- Steel Products and Component for Construction, 100%
- Pumps, Medium Voltage (MV) Motor and Associated Accessories, 70%
- Plastic Pipes, 100%
- Air insulated MV Switchgear, 5%-50%

Bids will be adjudicated in terms of the Preferential Procurement Regulations, 2017 pertaining to Preferential Procurement Policy Framework Act, 5/2000 and other applicable legislations, and either the 80/20 or 90/10 preference point system will be applicable to this tender, as determined by regulation 3(a)(ii). Preference points will be awarded to service providers using their B-BBEE status level of contribution. The bids will remain valid for 120 days. The Council reserves the right to accept all, some, or none of the bids submitted, either wholly or in part and it is not obliged to accept the lowest bid.
